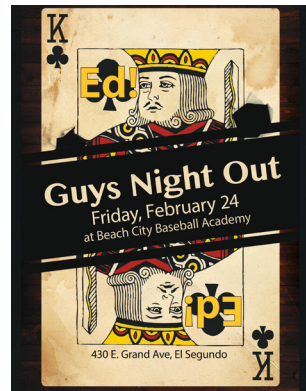
Fundraisers

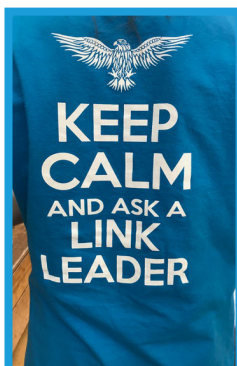
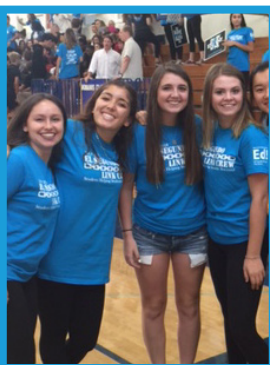
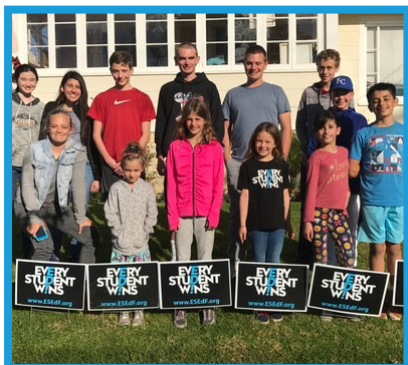
